ELIGIBILITY OF ARTIST

Hopi Arts & Cultural Festival is restricted to artists who are members of the federally recognized Hopi Tribe and can provide proof of membership of the Hopi Tribe.

ART EXHIBIT BOOTHS

Each 10' wide x 10' deep booth will not be furnished with any equipment, you will need to furnish your own canopy, table & chairs. Each 5' wide x 5' deep canopy will be provided except for any equipment which you will need to furnish (tables & chairs).

BOOTH DESCRIPTIONS

- **Individual (1 artist) – may show individually created and signed works.**
- **You may share your booth with an invited artist at an additional cost of \$50 per person (Limit 3 to a 10x10 booth & 2 to a 5x5 booth). All artists must meet the eligibility requirements.**
- **All artists must provide a City of Flagstaff Sales tax permit or pay an additional \$15 per artist for a permit for festival week-end.**
- **All Artists will be required to keep booth set-up until 5:00 P.M. Saturday & 5:00 P.M. Sunday.**

ART EXHIBIT BOOTH GUIDELINES

1. **All artists are asked to submit a piece of art for donation to help fundraise for Hopi sponsored program chosen for 2017.**
2. Registered artists must staff their booth during all official Festival hours of operation. NOTE: Artist aides will be available for breaks.
3. At the opening of the Festival, each artist display at least 8 (8) original works of art for sale.
4. No animals are allowed in exhibit booths, except service dogs.
5. Any artist who misrepresents himself/herself or his/her work shall be removed from the Festival and Booth space will not be transferrable.
6. All artists must conduct themselves in a manner that reflects the dignity of the event, and in a manner, that does not embarrass or reflect negatively on the Hopi Arts & Cultural Festival and its participants.
7. Festival reserves the right to prohibit the sale of any item or items deemed inappropriate without refund of booth payment.
8. Festival provides limited security at the Festival Saturday night. It is the responsibility of the registered artist to maintain adequate insurance coverage for the possessions and property in their booth. Festival will not be responsible for any loss, theft, accident or act of nature.
9. **Use of alcoholic beverages, drugs, and/or smoking by artists/exhibitors in Heritage Square or on the Street of Aspen is prohibited.**
10. No Walk-in booths available.
11. No stores or dealers are allowed.
12. If you cancel or are a "no show" you will not be eligible for a Refund.
13. Festival has the right to remove an artist from the Festival who fails to comply with the Festival Guidelines.
14. Festival reserves the right to assign artists locations in the best interest of the Festival and reassign booths due to artist cancellations or no shows. Booth assignments will be given at time of check in at the check-in table.
15. Tables, chairs, canopies, and weights will not be provided. **It is required by the City that you provided weights for each leg of your canopy, or you can/will be asked to remove your canopy.**

ARTWORK RULES AND STANDARDS

1. Artists must display original works of art for sale, created/handmade by the registered artist who occupies the booth. Artist cannot sell work made by someone else.
2. All art is subject to evaluation, if asked to remove an item please do so immediately.
3. Artists cannot display or sell any items that contain materials derived from animals which are considered endangered or might otherwise be considered in violation of Federal or Arizona state laws.
